"On the technical side, companies need to implement the ability to report on what PI they have as defined by the CCPA, and what they are using it for, in addition to providing the ability to delete non-essential information from their systems when requested," said EC Wise CEO Jack Hakim. "With the imposition of penalties for noncompliance, data breaches and the increased risk of civil suits, CCPA raises the bar for data management and security, areas in which EC Wise brings considerable expertise."
