Overview

Anthony Proscia is a partner at Kaufman Dolowich. Prior to joining the firm, Mr. Proscia worked at two well-regarded national insurance defense firms, where he handled all phases of litigation relating to professional liability claims, including lawyers, accountants, insurance and real estate brokers, as well as brokers and dealers. He had also defended corporate entities, public school districts and religious institutions against general negligence, employment and premises liability claims.

Mr. Proscia has also worked as staff counsel for an insurance company, where he prosecuted approximately 4,000 subrogation actions arising from motor vehicle accidents, including property damage, medical benefits and un/underinsured benefits claims. During his tenure, he secured settlement and judgment recoveries totaling more than \$10 million.
