Kaufman Dolowich is dedicated to promoting diversity by continually searching for ways to broaden and enhance our recruiting efforts. We are pleased to be pursuing Mansfield 6.0 Certification in 2023. In 2022, we achieved the highly coveted Mansfield 5.0 Certification. Our firm committed to reaching this goal last year, as one of 160 firms that participated in the 5.0 certification process. 2022 is the fourth consecutive year Kaufman Dolowich has reached a Mansfield benchmark, a testament to our commitment to diversity and inclusion. In 2021, Kaufman Dolowich was one of 118 firms to achieve Mansfield Certification 4.0.
