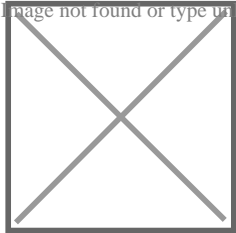


Michael Ganz Joins Kaufman Dolowich Long Island Headquarters as Construction Practice Partner, 1-10-2023
